
City of Newton Recycling

In an effort to reduce the volume of solid waste from entering the landfill, in 1999 the Harvey County Commission banned recycling materials countywide. This was meant to reduce the amount of materials taken at the landfill, preserve the life cycle of the landfill and reduce the amount that is transferred to out of county disposal sites.

In cooperation with Harvey County, the City of Newton adopted local recycling ordinances requiring mandatory participation by all residential trash customers. Providing recyclables to the county recycling facility.

HARVEY COUNTY AND THE CITY OF NEWTON'S PARTNERSHIP IN RECYCLING



The City of Newton and Harvey County have agreed to work together in the recycling process. The City of Newton will collect recycled materials such as plastics, glass, aluminum cans, newspaper, and cardboard. The City will provide containers similar to the picture on this brochure. Each household will receive one recycling container and one trash container. Customers will be able to purchases additional containers at their own cost if desired.

City recycling trucks will haul the recycled materials to the Harvey County Material Recycling Facility for processing.

The City of Newton and Harvey County plan on implementing the program in 1999.


The City of Newton and Harvey County have decided to recycle for several reasons. Here are just a few:

RECYCLING PRESERVES RE-SOURCES FOR OUR CHIL-DREN'S FUTURE



The use of recycled materials will help future generations with lower energy cost and preservation of the environment.

RECYCLING SAVES MONEY



Due to various regulations imposed by the federal and state government, local governments such as Harvey County and the City of Newton can no longer afford to place items that are recyclable in the landfill. Recycling decreases the amount of tonnage hauled to the landfill, which reduces the overall cost of refuse collection.

Recycling Preserves Energy and the Environment





According to figures from the Environmental Excellence Campaign "Producing a ton of recycled paper uses 64% less energy, 58% less water; results in 74% less air pollution, 35% less water pollution; saves 17 pulp trees and creates five times more jobs than producing a ton of paper from trees."

CHANGES TO CURRENT REFUSE COLLECTION PROGRAM.

- 1. Curbside pick-up (except extreme cases).
- 2. Once a week pickup of trash and recyclables.
- 3) No extra charge to citizens.
- 4) Containers provided for trash collection.
- * All changes will occur in 1999.



The City of Newton changes from twice a week garbage collection to once a week trash & recycle collection.

The City of Newton changes from alley collection to curbside collection.

The City of Newton provided one 90gal cart for trash and 2 recycle bins.

In 2012 the City of Newton converts to single-stream recycling, providing residents with 1-90gal trash cart & 1-90gal recycle cart. The city also adds numbers 3 through 7 plastics to the recycling stream, including numbers 1 and 2.

In 1999 South Central Recycling manages the recycling center at the Harvey County Landfill.

In 2001 Harvey County Landfill changes to a transfer station, hauling Harvey County trash to the Reno County Landfill.

In 2004 the contract to manage the recycling center was given to Stutzman's Refuse Disposal.

In 2012 Waste Connections takes over the contract to manage the recycling center.

At the City of Newton we collect trash & recycle 4 days per week. We run 2 routes each day we collect materials.

We run 2 trash trucks & 2 recycle trucks, one for each route, 10 hour shifts.

All collected materials are taken to the Harvey County Transfer Station.

Our recycle rate is about 30 - 35% for the City.

In 2017 collected 1,537 tons of recyclables.
